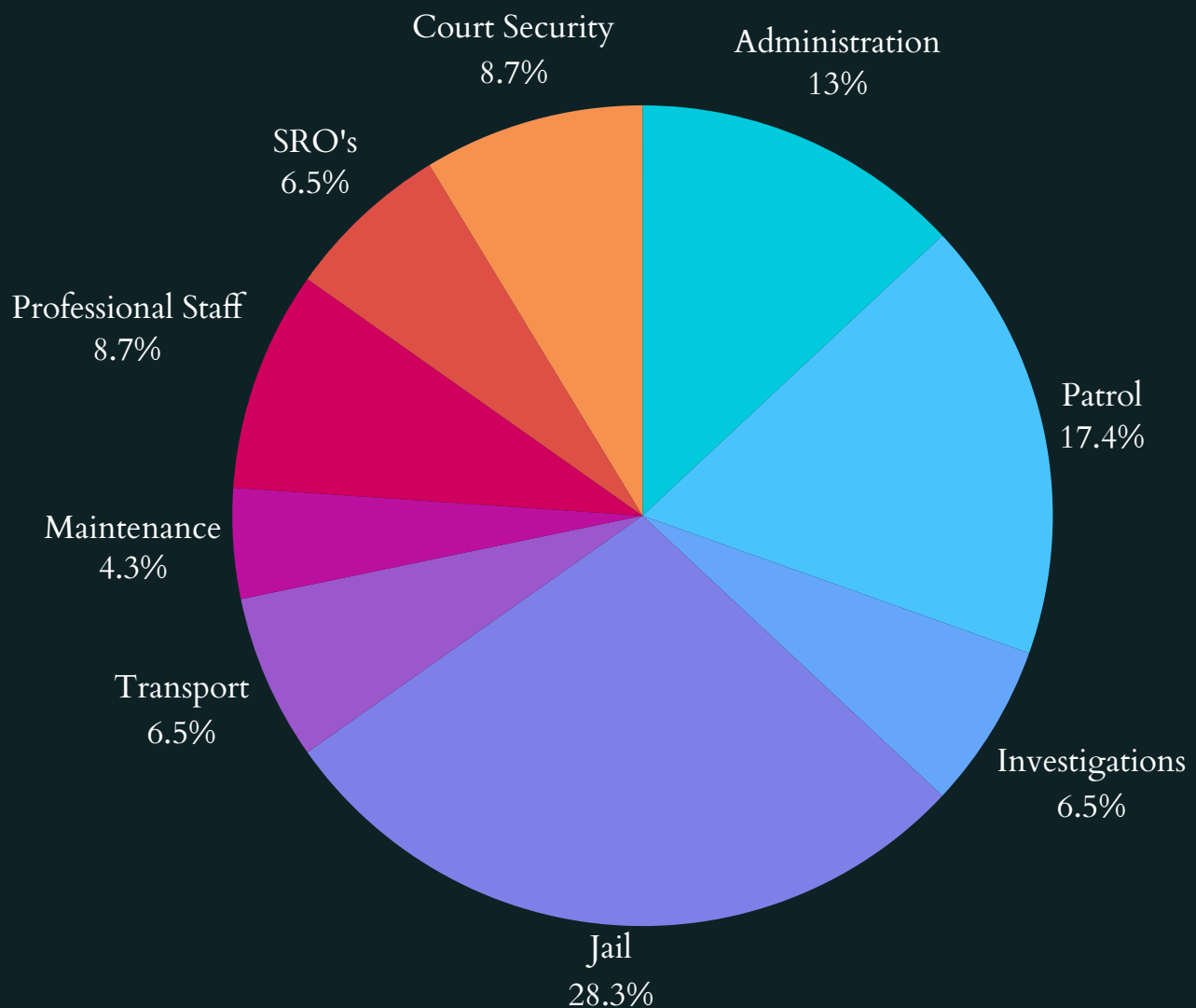

# Fiscal 2024 Plans

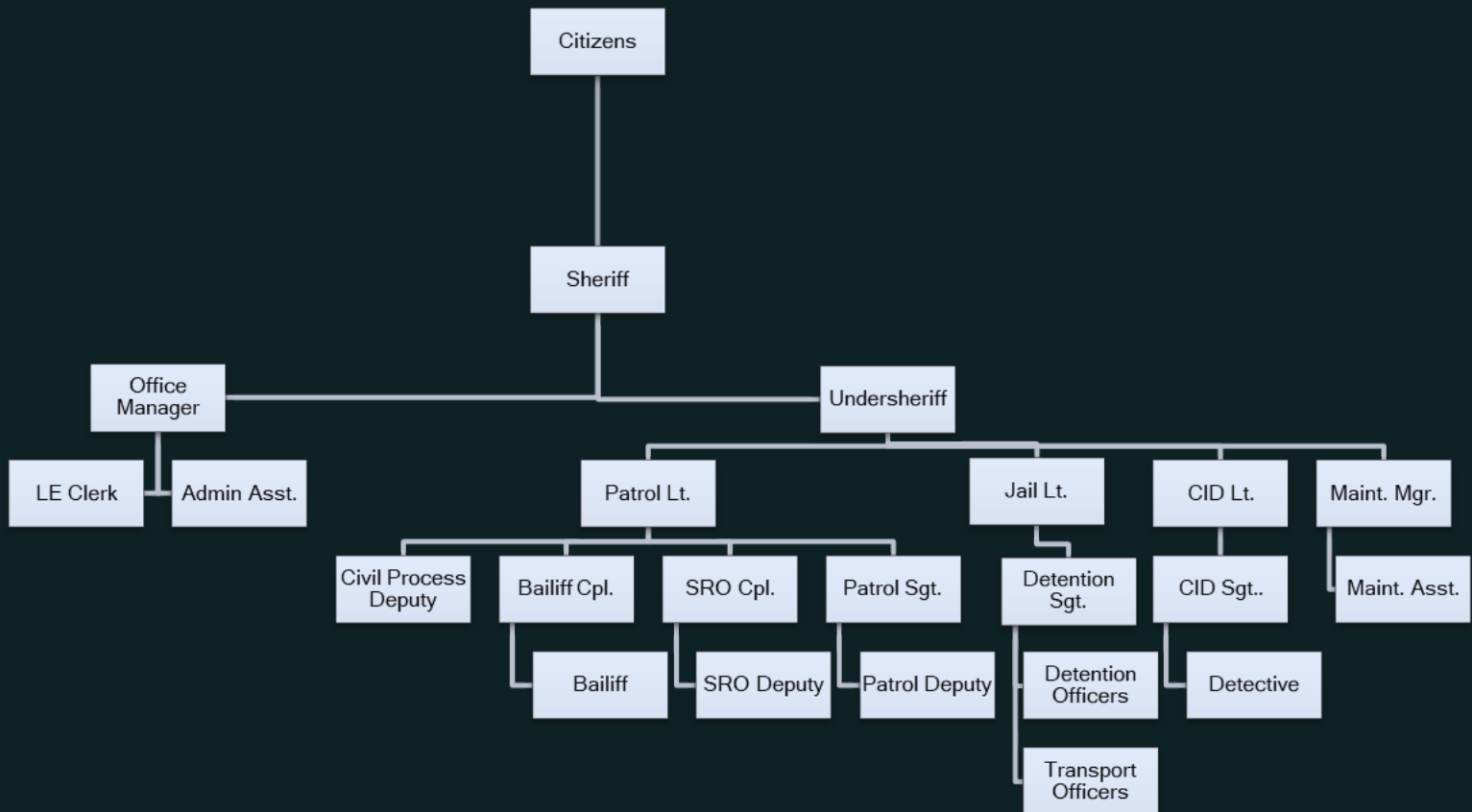
1. Implement an employee health and wellness program that will assist employees with mental and physical health needs.
2. Enhance crime prevention through technology and resources, while improving coordination and information sharing among all law enforcement partners.
3. Improve roadway safety to reduce traffic fatalities by increasing high visibility traffic enforcement with emphasis on speed and aggressive driving, distracted and impaired driving, and occupant protection.
4. Enhance response for mental health calls by expanding on Crisis Intervention training for all CCSO, including de-escalation techniques.
5. Building partnerships and community trust by educating the community on misconduct reporting, prioritizing resources for the needs of different areas of the county, and developing a program that utilizes citizen resources for safety at special activities and events.
6. Continue being transparent and fiscally responsible in our efforts to provide a high standard of service to our community and its residents.

# Staffing Breakdown by Division

As of December 1, 2023, the Crawford County Sheriff's Office employed 46 people in 5 divisions. There are currently 4 positions available office wide.



# Organizational Chart



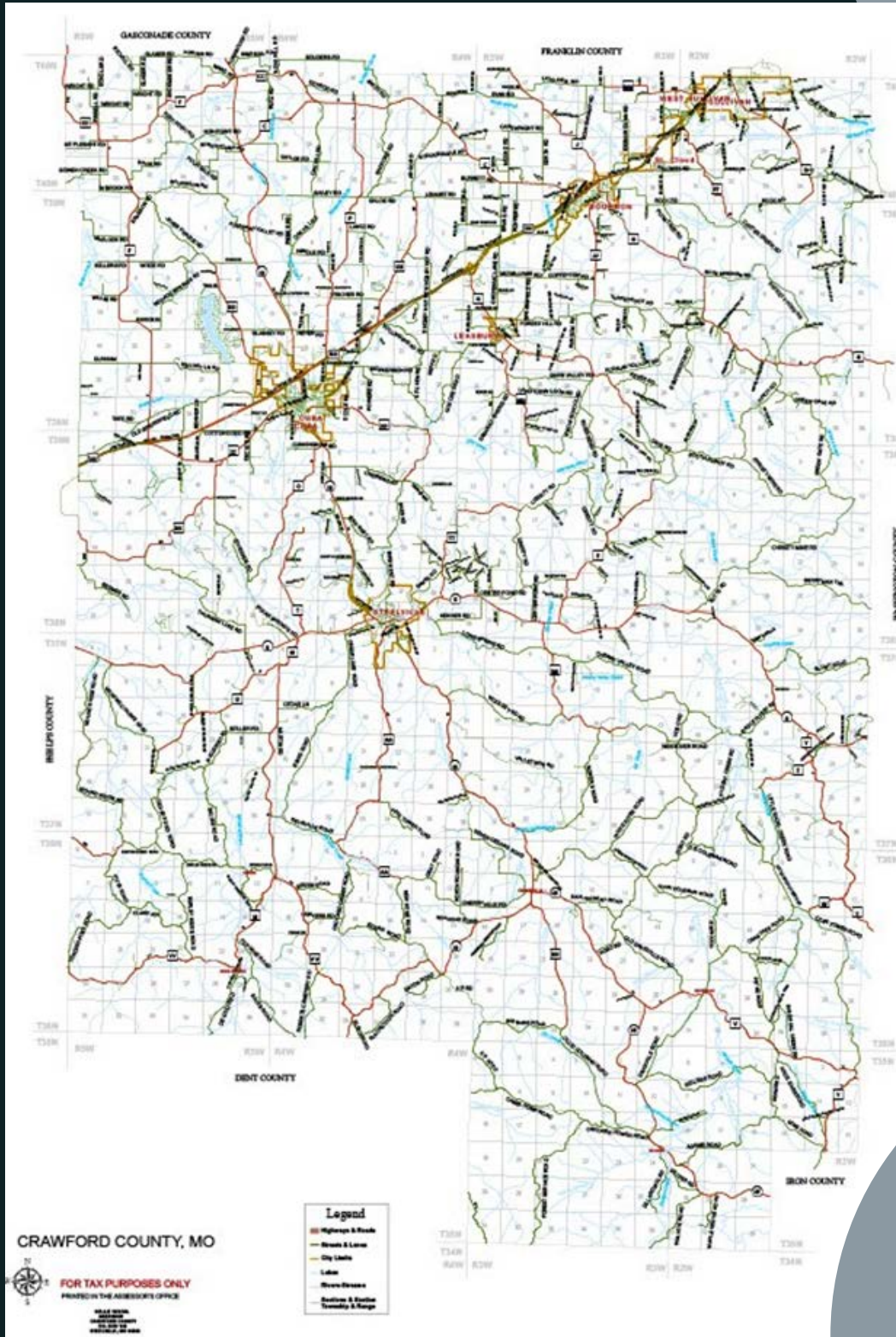


# Patrol Division

The Crawford County Sheriff's Office patrol deputies' police all of the unincorporated areas of the County. Those are the areas outside of the cities of Steelville, Bourbon, and Cuba. Crawford County is approximately 744 square miles and home to over 23,000 residents.

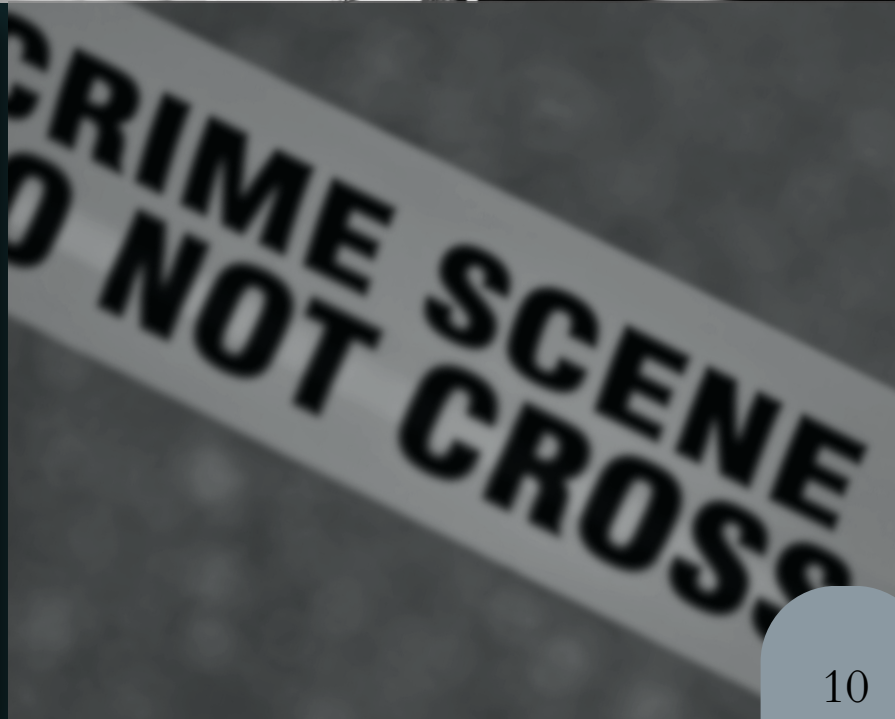
The Crawford County Jail is a 126-bed facility that houses local, state, and federal inmates. For nearly 20 years, we have partnered with the United States Marshals to house pre-trial detainees for the Eastern District of Missouri. The jail has been operating since 2004 with employees working 24 hours a day, 7 days a week, 365 days a year.

The Jail division employs our detention officers and transportation officers.



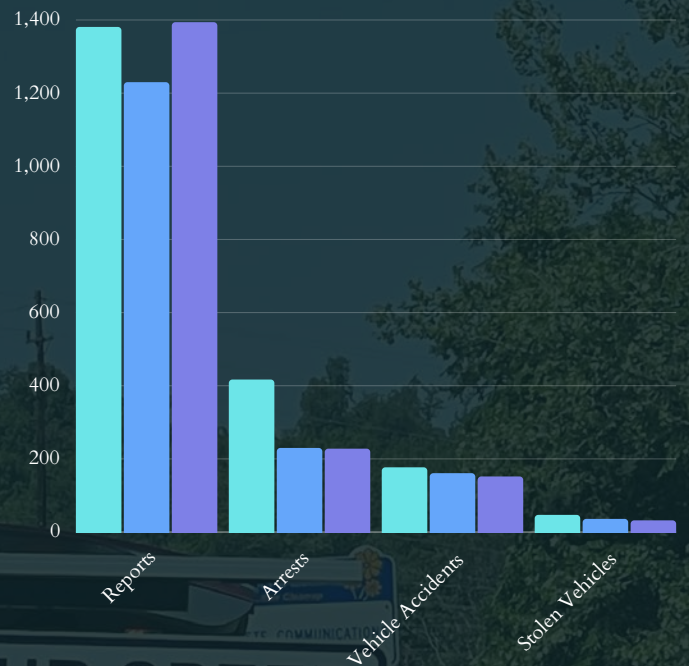
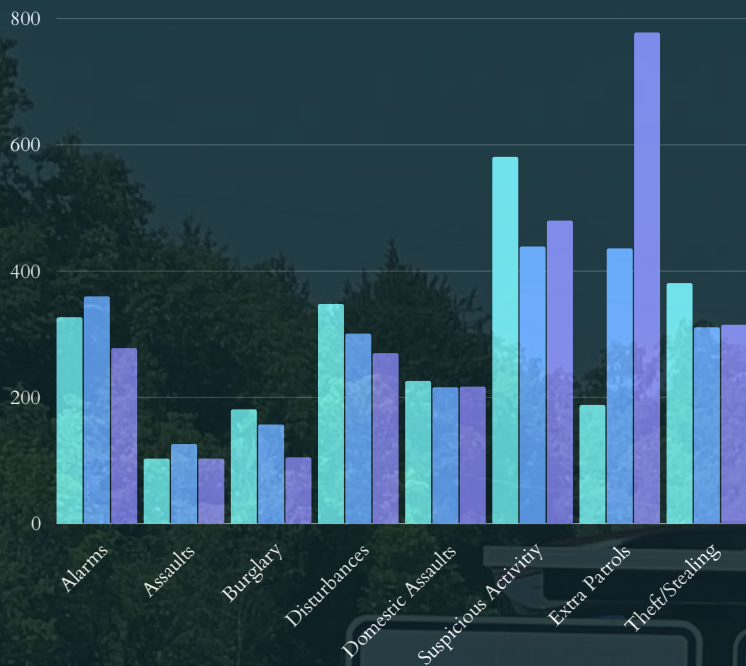
# Criminal Investigations Division

Our CID is responsible for investigations of homicides, assaults, missing persons, property crimes, and sex crimes. They also collect evidence and provide sex offender compliance enforcement. Other duties include collecting evidence, performing background checks, and conducting internal investigations.

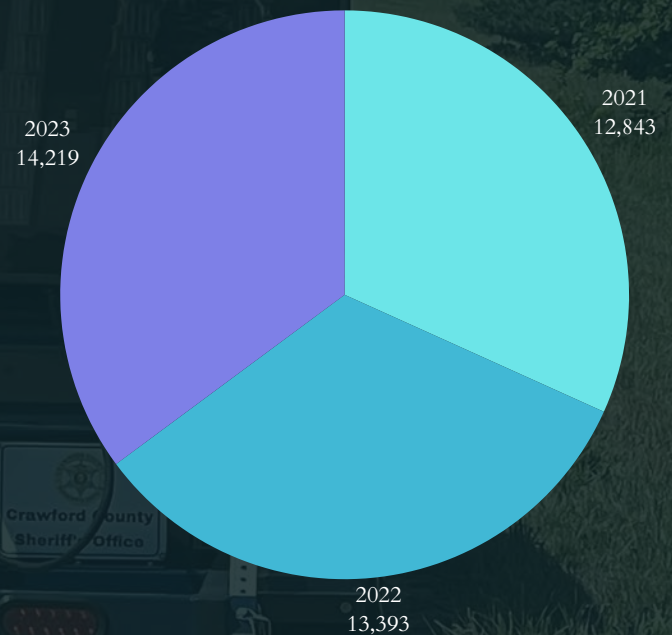

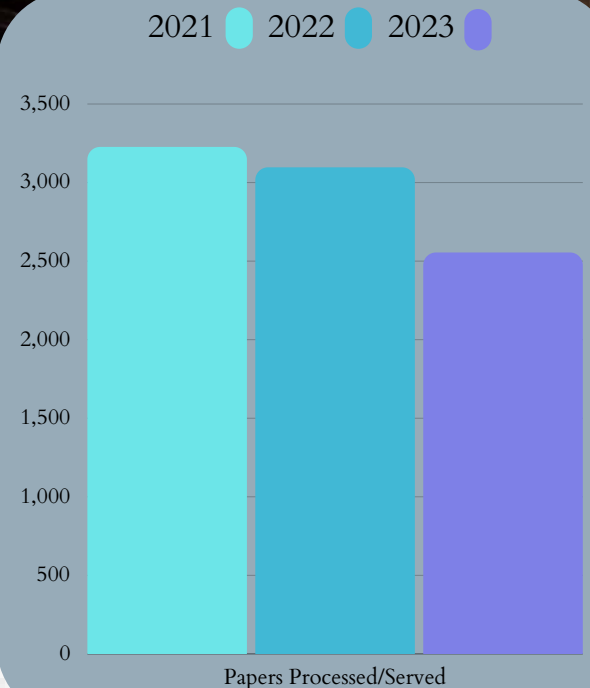

# Civil Process Court Security



Our Civil Process Division prepares various court papers for service including subpoenas, garnishments, affidavits, replevins, levies, and summons. On average over the last three years, we have processed and served over 2900 papers. Our Court Security oversees both Circuit and Associate Courts, by screening those attending court for contraband/weapons and providing bailiff duties inside the courtroom.

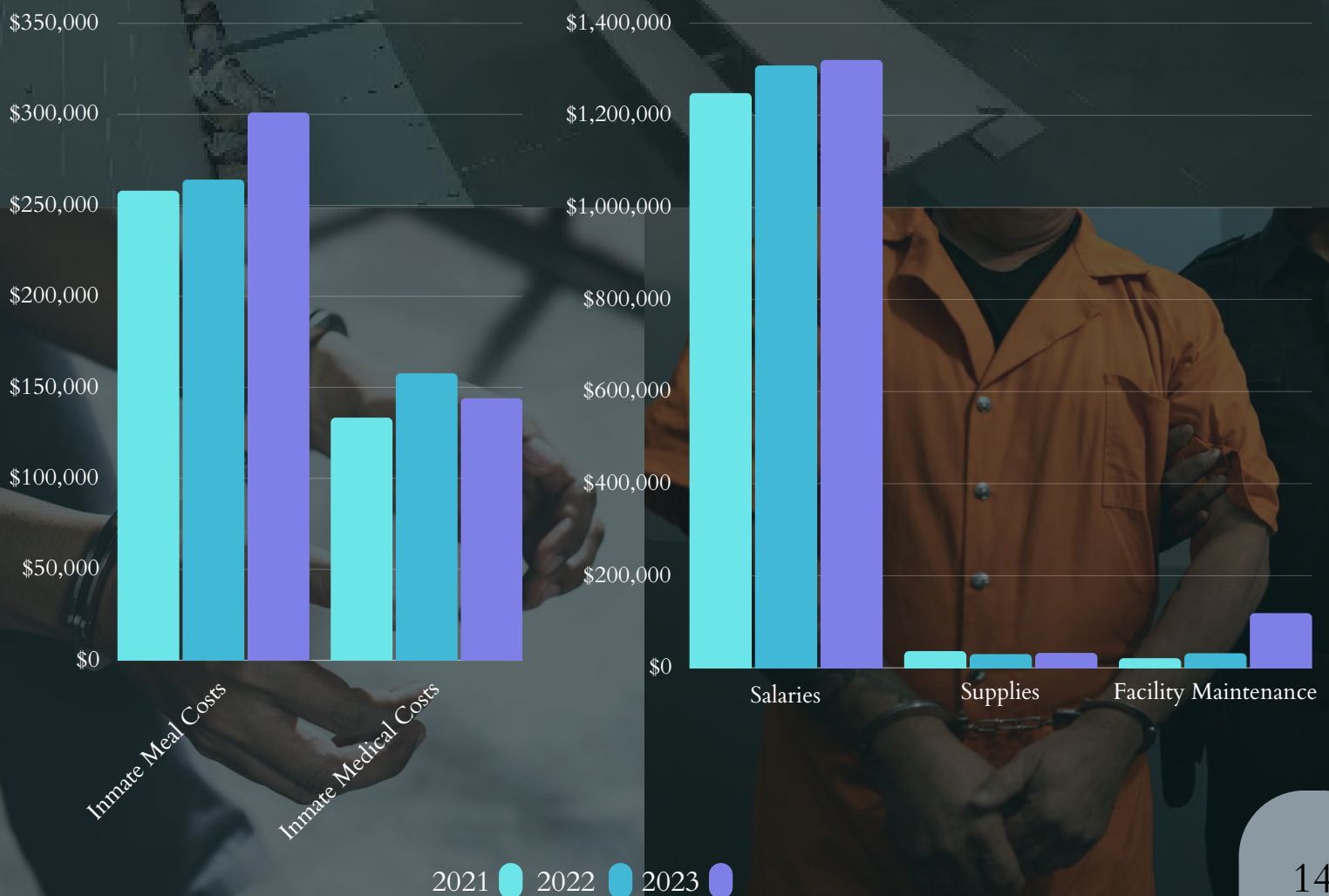

# Detention Facility

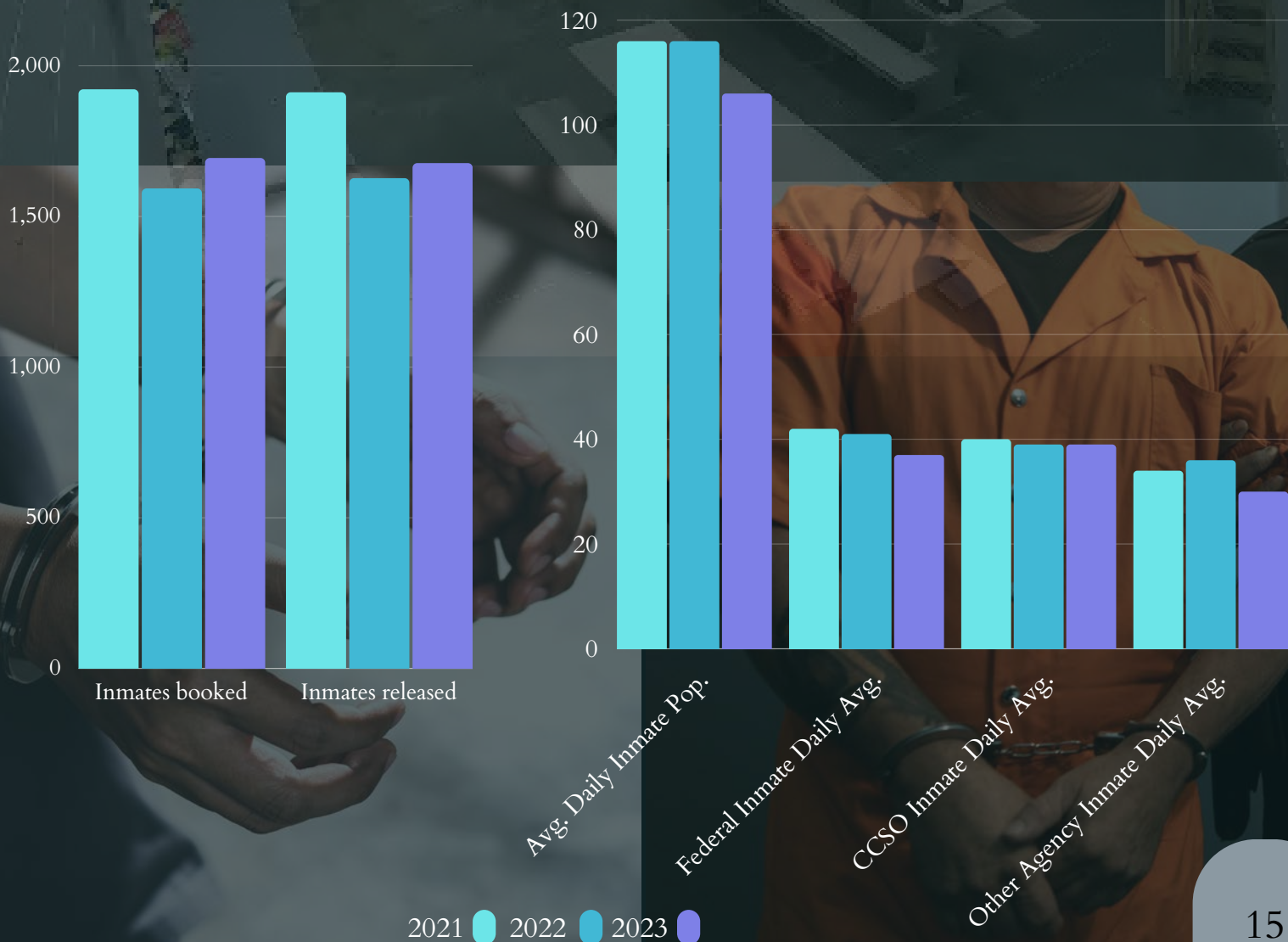
The daily cost to house an inmate has risen 41% in the last 3 years. In 2021 the cost was approximately \$56.00 to house an inmate, in 2023 the cost has risen to \$79.00. We have seen a dramatic increase in the cost of food which has risen 21% since 2021, a major driving factor in costs. Competitive wages, medical care, facility supplies, maintenance, and other factors are also calculated in the costs.





# Detention Facility

In 2023 the Crawford County Jail implemented a \$100,000 video surveillance improvement to our facility, which updated our antiquated equipment and technology that had been in place since the facility was built in 2003-04. This improvement provided an increase in security with the addition of over 60 new cameras.



# Prisoner Transport

The purchase of a new transport van in 2023, with the proceeds from jail commissary and jail phone commissions, allowed for a much-needed addition to our transport fleet. Our transport teams traveled over 81,000 miles in the last year transporting prisoners.

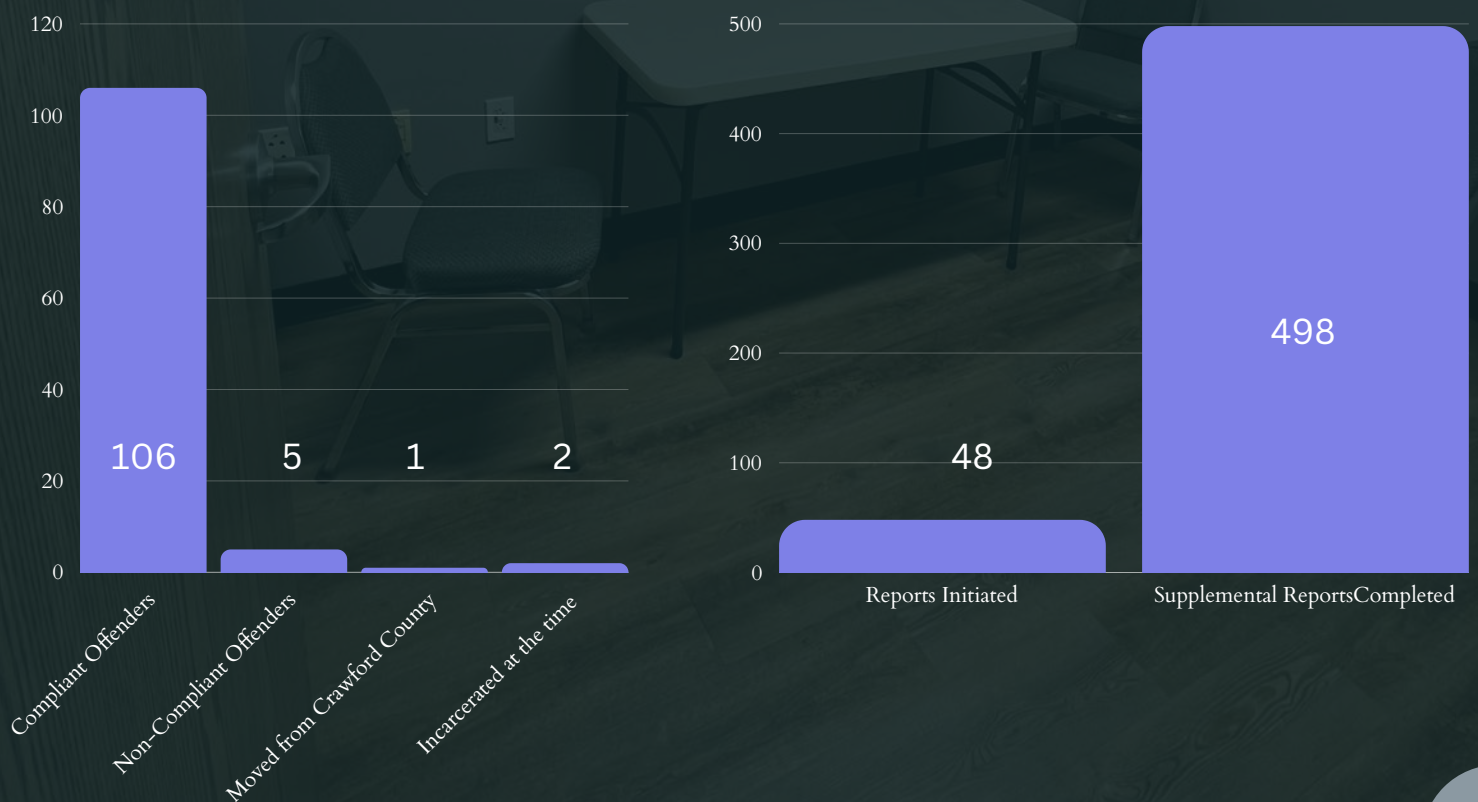

# Criminal Investigations Division

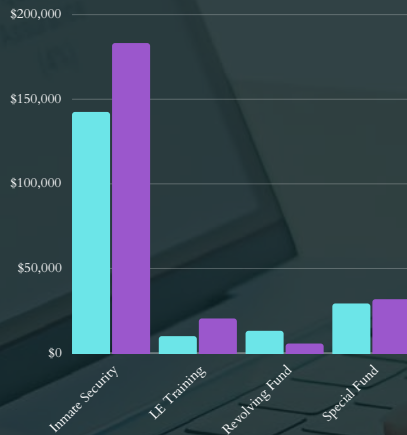
The Criminal Investigations Division conducted two different compliance checks on sex offenders this year. In February a compliance check was conducted with the assistance of the US Marshal's Service for 114 registered sex offenders residing in our county. As a result of that check 5 offenders were found to be non-compliant and charges were filed for those violations. In October during Halloween night, spot checks were also conducted to ensure compliance with RSMo. 589.426 the sex offender Halloween Restrictions. None of those checks resulted in violations being discovered. One of CID's main responsibilities is to follow up on investigations that result from reports taken from our road patrol division.



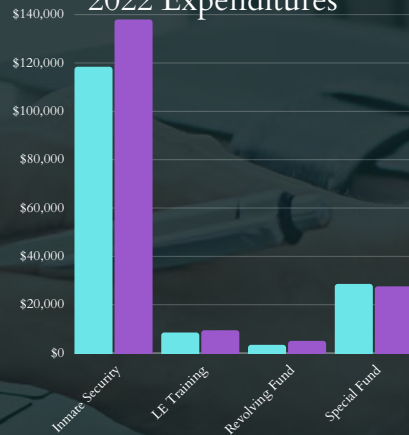

## 2022 Revenues



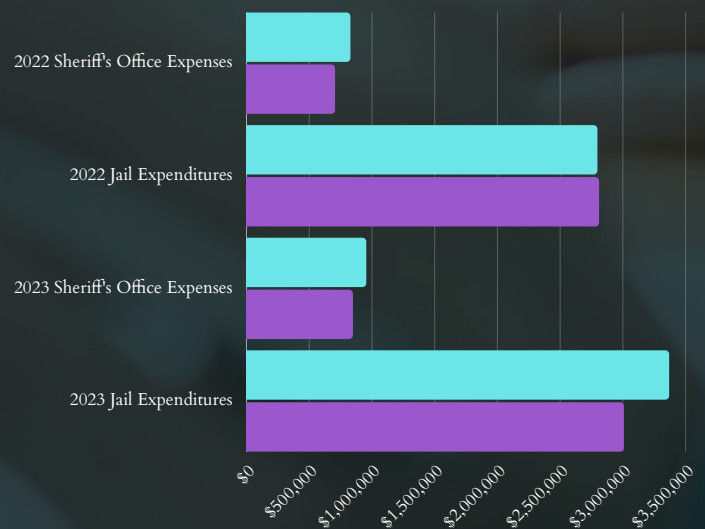
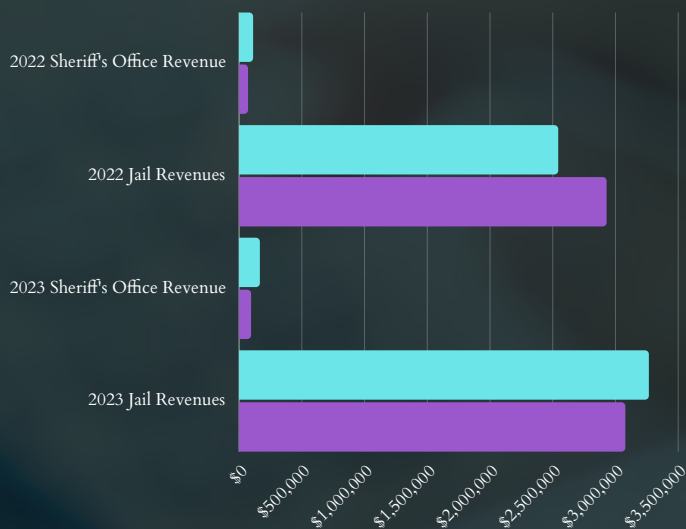
## 2022 Expenditures
